
#### Cycle 3: Benefits of our Justification, 5:1-7:25

- Hypophora, 6:1-7:25...4 Questions!
  - 1. 6:1, "Shall we sin so that grace may increase?" "May it never be!"
  - 2. 6:15, "Shall we sin because we are not under Law?" "May it never be!"
  - 3. 7:7, "Is the Law sin?" "May it never be!"
  - 4. 7:13, "Did that which is good become a cause of death for me?" "May it never be!"

### "A Biblical View of Salvation" Based on Romans 6

Unbeliever

Believer



Romans 6:17-18; 20-22.

# Then is the Law sin???, 7:7-12 May it never be!

- The Law Reveals The Sin, 7:7.
- The Law Provokes The Sin, 7:8.
- The Law Revives The Sin, 7:9.
- The Sin uses The Law to produce "death," 7:10-11.

But it can never produce righteousness!!

Unsaved Saul of Tarsus could never achieve righteousness by means of the Law!!

#### AND NEITHER COULD YOU!!!

"For by grace you have been saved, through faith...!"

### Arguments for Romans 7:13-25 describing Paul's life as an unbeliever:

1. THE CONTEXT! The question in v. 13, and the subsequent answer and explanation follow directly the discussion in 7:7-12!

The "death" of v. 13 and v. 24 is the "death" of 7:9, 10, 11, and 7:5.

The Law did not cause the "death,"

The Sin did!

### Arguments for Romans 7:13-25 describing Paul's life as an unbeliever:

The man in 7:14 is "of flesh" ←> "Sarkinos," meaning "made of flesh." That's all he was...flesh! "Carnal" is misleading.

- Arguments for Romans 7:13-25 describing Paul's life as an unbeliever:
- 3. The man in 7:14 is "sold into bondage to The Sin."

Recall what happened at salvation!!!

The believer is freed from slavery to

The Sin at Salvation!

This CANNOT be a believer!

### Arguments for Romans 7:13-25 describing Paul's life as an unbeliever:

4. The man in 7:23-24 is a "wretched man," a "prisoner of the law of The Sin in his members.

Jesus promised "abundant life," (John 10:10), not wretched slavery!

### Arguments for Romans 7:13-25 describing Paul's life as an unbeliever:

5. Romans 8:1 finally gives the victory... freedom from condemnation, "for those who are in Christ Jesus."

There is nothing BUT CONDEMNATION in Romans 7:13-24!

But the believer is free from condemnation!

#### My conclusion...

Based primarily on the CONTEXT of Romans 7 And the development of Paul's argument in the hypophora section of this 3<sup>rd</sup> cycle, Is that Romans 7:13-15 describes Paul's frustrated, defeated life as a Jewish man trying to achieve justification by the works of the Law, and failing miserably.

  22-23a
- Paul's Constant Performance of Evil: 23b
- Paul's Bondage to The Sin: 24

Paul's parenthetical outburst of thanksgiving to God Paul's parting summation of his struggle with sin.

IF Romans 7 is describing the experience of a person before salvation...

AND IF Romans 8 is describing benefits of a person AFTER salvation...

THEN you would expect to see many CONTRASTS
between Romans 7 and Romans 8

#### CONTRASTS BETWEEN ROMANS 7 & 8

Romans 7	Romans 8
"in the flesh," 5	"NOT in the flesh," 9
"in the flesh," 5	"In The Spirit," 9
"not saying that the Law was BAD," 7, 13	But the Law was IMPOTENT, 3
unable to fulfill the Law, 14-24	"requirement of the Law fulfilled in us!" 4
"prisoner," 14, 23-24	"set free," 2
Needing to be set free, 24	Having been set free, 2
No mention of the Holy Spirit (except verse 6)	MANY (12!) references to the Holy Spirit

#### Romans 5 and 8: Benefits of our Justification:

- Peace with God, 5:1.
- Standing in grace, 5:2.
- Hope of glory, 5:2.
- Meaningful trials, 5:3-5.
- Proven Love, 5:6-8.
- Freedom from wrath, 5:9.
- Reconciliation, 5:10-11.
- Freedom from Adamic Guilt, 5:12-21.

#### Romans 5 and 8: Benefits of our Justification:

- Freedom from condemnation, 8:1.
- Freedom from the law of The Sin and the death,
   8:2-4
- We ARE "according to the Spirit" and have the mind of the Spirit, 5-8. (Translation problems!)
- We are IN THE SPIRIT, 8:9. (Sphere of existence!)
- The Spirit is in us, 8:9 (Indwelling!)
